### INSTRUCTIONS

PRINT ALL ENTRIES IN CAPITAL LETTERS. Use either black ink, black ball point pen or pencil. Two black and white photos taken within 30 days of application (size 1 1/2 x 1 1/2) and a \$2.00 fee must accompany each application. Finger printing, if needed, may be accomplished at any precinct station house (during the initial 90 day Registration Period unless otherwise extended) or at the Gun Control Unit at Police Headquarters.

The following is an abridgement of Police Regulations which prohibit the purchase, possession, having in custody or carrying (encased and unloaded) a rifle or shotgun within the District:

Under 21 years of age, (except persons 16 to 21 with parental permission from their parent or guardian); mental disorders; chronic alcoholism; drug use; previous conviction of a crime punishable by imprisonment for more than 90 days; conviction of a crime involving violence or weapons offenses; keeping a pistol for, or intentionally making a pistol available to a person so convicted; certain physical defects; or been involved in firearms mishap.

Licenses issued to persons under the age of 21 will be restricted to use in sport and recreation purposes, during daylight hours and while in the presence of a person over 21 years of age licensed under this Article.

I do not answer to one or more of the descriptions listed above and I am not otherwise ineligible to purchase, own, possess or carry (encased and unloaded) a rifle or shotgun by the existing Firearm Regulations.
